**General Board Meeting Minutes**

Wednesday, November 4, 2015

Porter Ranch Community School Multipurpose Room, 12450 Mason Ave., Porter Ranch

**1. Welcome -- President Paula Cracium called the meeting to order at 6:06 p.m.**

Reminder to sign in and that it is completely optional and not required for attendance. Ms. Cracium noted.

**2. Roll Call – Secretary Eric Nam**

Board member Sean O'Rourke (Treasurer 1) was absent.

The PRNC quorum (the minimum number of Board Members needed to be present to take binding votes on Agendized Items) is seven. All 11 of the 11 Board Seats were filled either by appointment or election. Also in attendance were approximately 150 stakeholders and guests.

7. Special Presentation and Q and A regarding the So Cal Gas Natural Gas Leak in the Aliso Canyon Storage Field

Paula Cracium stated that the PRNC worked hard to bring together a group of individuals to answer all questions that stakeholders may have regarding the gas leak in the community. Ms. Cracium asked that everyone who wished to speak to keep it to a 3 minute time limit in order to give everyone an opportunity to be heard.

Bret Lane, Gas Company, COO started off by apologizing to those in attendance for the poor communication from the Gas Company with regards to notifying the community timely but hopes to improve that so that the lines of communications continue to stay open. Mr. Lane stated that he has been onsite every day trying to resolve the gas leak Mr. Lane stated that he was there to answer all questions as well as the rest of the panel.

Mr. Lane stated that the leak was first discovered on Friday, October 23, 2015 and the Gas Company immediately called the appropriate departments in order to assess the situation. Jimmie Cho, Senior VP for Gas Operations and System Integrity also offered his apologies to the community and stated that "we have to do better". Mr. Cho said that natural gas is odorless and that is the reason that mercaptans are added as an odorant and that is what the residents of Porter Ranch had been smelling over the last several days.

Mr. Lane stated that the Gas Company has called in one of the top two experts in the world to assess the leak. He stated that the leak itself is unusual in that ice has formed around the gas line thereby making it difficult to get to. The Gas Company has brought in special equipment which will take a few days to assemble in order to begin try to stop the leak. However, the Gas Company does have other plans in place in the event that special equipment brought in does not work.

Mr. Lane and Mr. Cho then shared a brief power point presentation with everyone in attendance to try to give them a better understanding of what was happening. Their main concern with the gas leak is not only to insure the safety of the community but to insure the safety of their workers who are working directly at the site. The site is monitored twice daily, usually once in the early morning hours and in the evening. The timing of the monitoring is done when the winds are still in order to get an accurate reading. They encouraged everyone who smells gas to give them a call so that they can get a representative out to their location to assess the smell.

Jerrod DeGonia San Fernando Valley Field Deputy, County Supervisor Michael Antonovich wanted to thank the PRNC for changing their agenda at the last minute and allowing the panel to come in to speak with the community. Mr. DeGonia said that the communications between all the agencies is flowing and the presence of all agencies is overwhelming.

Mr. Bill Jones, County of Los Angeles Fire Department, Health and Hazardous Materials Division said that his department has teams on call 24/7 and that they roll out immediately from their offices and homes and that they are there to insure that the public's health is protected. Mr. Jones said that he and his team will be onsite until the gas leak is resolved.

Edwin L. Pupka, Senior Enforcement Manager, Office of Engineering and Compliance South Coast AQMD said that his agency covers four counties, Los Angeles, Riverside, San Bernardino

and Orange. Their primary function is to regulate the air pollution and that they have inspectors in the field to make

sure that compliance is in place. Mr. Pubka said that since October 24<sup>th</sup>, his office has received over 180 complaints. He encourages anyone who has a complaint to call 1-800-CUT-SMOG. Mr. Pupka said that he has staff staged in the area that will spend time with the complainants to interview them. He encourages everyone to ask questions.

Katie Butler County of Los Angeles Department of Public Health, Health Impact Assessment Analyst, Environmental Epidemiologist said that her department was reviewing air samples and would like to review the samples for the short and long term affects that it will have on individuals. Ms. Butler said that no one should have to smell the gas in the air and hopes that the issue will be resolved shortly.

Numerous stakeholders then got up and spoke wanting to know what was being done about the gas leak. Many expressed their concern that they and their family members have been getting sick with many complaining of headaches, dizziness and nose bleeds. They also stated that their family pets have fallen ill. Many residents were concerned with the long-term affects of the gas leak and how soon would the situation be resolved. Others expressed concern with the fact that many of the medical facilities were not aware of the gas leak and therefore were not prepared to treat those that had become ill.

Other concerns were for how often the lines were tested and did they show erosion. Another resident requested that another monitoring station be put in at the top of the hill closet to the site. Most residents were very angry in the lapse in time in which they were notified, because initially the Gas Company denied that there was even a leak.

Overall the panel answered all questions to the best of their ability stating that they are constantly assessing the situation and when they know more they would let the residents of Porter Ranch know. However some questions could not be addressed and the panel encouraged those residents to meet with them after the meeting so as to get specifics of the particular concern so that they could then follow-up with those residents at a later date.
