PRNC Meeting Minutes: September 21, 2004, 7pm

The Porter Ranch Neighborhood Council (PRNC) held its monthly meeting on September 21st at the Shepherd of the Hills Church. Three separate speakers made presentations covering the proposed LAX Master Plan, issues confronting the PRNC, and Community Emergency Response Team training. A number of public announcements were made and handouts on the City's new alarm ordinance and a Center For Disease Control CD on the West Nile Virus were made available to attendees.

The first speaker was Ms. Shirlene Sue, Senior Management Analyst, with the Los Angeles World Airports. Ms. Sue covered the details of the proposed LAX Master Plan (Option D), which included a reconfigured north airfield, redeveloped central terminal area, an off-site ground transportation center, consolidated rental car facility, an automated people mover, an intermodal transportation center, and a Green Line connection. Ms. Sue also discussed the cost of the proposed expansion and how the project will be financed. Part of the cost will be funded by increased passenger fees. The second speaker was Mr. Greg Nelson, General Manager, of the Department of Neighborhood Empowerment (DONE). Mr. Nelson distributed DONE's new brochure and presented an overview of his Department's role in empowering neighborhood councils. He also addressed specific issues confronting the PRNC such as contracting restrictions, accepting donations, check processing delays, and DONE's recommendation to postpone the PRNC election to January or February of 2005. The third speaker was Mr. Patrick Hall, Coordinator - Battalion 15 CERT, who spoke on the role of the Community Emergency Response Team (CERT) and the free training program offered by the Los Angeles Fire Department, Disaster Preparedness Unit, through the CERT Program. The training includes an introduction to the CERT Program, earthquake awareness, disaster fire suppression techniques, disaster medical operations, light search and rescue operations, team organization and management, terrorism, and a course review.
