## VALLEY ALLIANCE OF NEIGHBORHOOD COUNCILS (VANC)

### NOTES FROM MEETING: AUGUST 11, 2016

Board Members Susan Gorman-Chang and Cheri Derohanian attended this meeting. For agenda of meeting, see Attachment 1.

#### 1\* NEIGHBOOHOOD EMPOWERMENT ADVOCATES

We were given a list of which Neighborhood Empowerment Advocate serves which Neighborhood Council (NC). (See Attachment 2). Porter Ranch Neighborhood Council (PRNC) is in Region 2, Northwest Valley, and served by Melvin Canas.

Neighborhood Empowerment Advocates Melvin Canas, Barry Stone, Kathleen Quinn spoke on areas they get questions about most often related to Neighborhood Councils (NC). Some of those questions are as follows:

How many Board members can be on a committee?

Answer: 1 less than the majority or quorum. So if your NC has a quorum of 6, then one less would be 5, so that 5 is the maximum amount of board members that can be on a committee. The number of stakeholders on a committee, however, has no maximum.

It is possible to do a joint NC Board Meeting and Committee Meeting, if it is agenized as such.

Why are there and what are some of the limitations of communication under the Brown Act?

Answer: These limitations are to avoid secrecy in government. All discussions should be conducted at public meetings. A serial communication may involve a series of individual communications that when taken as a whole involve a majority of the Board members. A serial communication is a violation of the Brown Act. See Attachment 3 for more detailed Q & A on the Brown Act.

How do the postings of a meeting work?

Answer: NC meetings must be posted 72 hours prior to the meeting for a regular meeting on the NC website plus one physical location posting and must be forwarded to <u>NCsupport@lacity.org</u>.

How do we get help with Americans with Disabilities Act (ADA) compliance for a Board Meeting?

Answer: Put ADA contact information on your NC website for anyone who needs assistance for a disabled person(s) to attend the NC meeting. Submit a request, with as much notice time as possible, to VANC Dept. of Disability.

For a need of a professional translator, as well, give as much notice as possible.

Who is our Funding Representative? What is our Funding Appr #?

Answer: Janet Hernandez & Appr# 1090 for PRNC. (See Attachment 4 for complete list for all NC).

How long does a Funding Request take to get?

Answer: From 5 to 8 business days from submission to getting the funding code.

Can a NC Board member endorse a candidate?

Answer: Yes, they can *personally* endorse a candidate and note their title as a NC Board member for "identification purposes only."

Can a NC endorse a candidate?

Answer: No

Can a NC endorse a ballot measure or proposition?

Answer: Yes, but NC cannot expend any city funds for this. See Attachment 5 for NC and Ballot Measure/Lobbying/State & Federal Legislation Do's and Don'ts.

What is the Grievance Procedure Timeline?

Answer: Within 30 days of the event, a grievance must be filed and within 7 days it is forwarded to NC in question. It goes through the process, passing from the NC to DONE and if not resolved, may go onto an appeal with the Department of Neighborhood Empowerment, Regional Grievance Panel, etc. See Attachment 6 for path & timeline of entire process.

Can I get my certificate online if I took the live Ethics Training?

Answer: No. Kathleen Quinn can get a pdf for you if you took the live training. There was no certificate issued at the live training, though attendees did sign in at the live training.

The Ethics and Funding Training should be referenced at every NC Board meeting to ensure each Board Member is up to date on their training. This is important because without up to date training, a NC Board member is not allowed to vote!

#### 2\* NC FUNDING FOR UPCOMING FISCAL YEAR

The funding will be \$37,000.

#### 3\* TRANSFER OF ADMINISTRATION OF NC FUNDING PROGRAM

The administration of NC funding will be transferred from Department of Neighborhood Empowerment (DONE) to the City Clerk staff. (See Attachment 7 Draft Ordinance dated June 23, 2016.) Per the draft, "hiring, staff training and implementation of the procedures in the City Clerk's Office will be required in advance of the transfer."

4\* NC CONGRESS

This is scheduled for Saturday, September 24, 2016 8:00 am – 4:00 pm downtown at City Hall. They will have dozens of workshops for us to attend on a variety of subjects. New NC Board Members especially are encouraged to attend, but even veteran NC Board Members will have workshops that interest them and from which they can learn a great deal.

#### 5\* VANC PLANNING FORUM & MIXER

See Attachment 8. This is at CBS Studios in Studio City from 5:30 – 9:30 pm. There will be an upcoming flyer on this event.

To attend both of these events is \$500, though NC can decide to send less money to VANC for this if they choose. The amount of money collected drives the amount/type of food & beverages purchased from the vendor. VANC suggests you put this in your NC budget if you want to send someone. This will entail presenting the motion and passing the motion to spend the \$500 (or a lessor figure) to send one or more Board Members to these two events. The NC would write ONE check for the Planning Forum a Mixer for \$500. Check is made out to JCS Catering Company. Contact Vic Viereck, VANC Treasurer at <u>VicViereck@sbcglobal.net</u> or 818-985-9174 for more information. This represents an advanced payment, but this is an exception approved by DONE. These two events are very important in that every city official seems to attend, so you get a lot of face time with them that you would not get under most other circumstances.

#### 6\* NC BUDGET ADVOCATES

The current list of newly elected Budget Advocates is on Attachment 9. PRNC is in Region 2, and our Budget Advocate is Brian Allen. We are encouraged to include an Agenda Item at each NC Meeting that covers updates from our Budget Advocate, which can be communicated via the NC Budget Representative(s). It is very important because the Budget Advocates are our voice in the city's budget process, so keep in touch with them and report to your community at each NC meeting.

#### 7\* COMMUNNITY IMPACT STATEMENTS (CIS)

Discussion was held regarding whether NCs are using their 5 minutes to testify at each and every LA City Council and committee meetings. This is such a powerful tool at our disposal to have our community's concerns heard.

Glenn Bailey, Northridge East NC, gave us this google doc for NC to use which is updated regularly, to track all Council Files for Neighborhood Councils. It is at <u>http://goo.gl/iohNB4</u>. Some upcoming items are:

Council File 16-0585 on a Coyote Management Program Council File 15-1022-S2 on improving Neighborhood Council Elections Council File 04-1935-S12 on training for NC election volunteers

Glenn recommends agenizing several Council Files that are relevant to your particular neighborhood community and file Community Impact Statements on those that are approved. This is another tool at our disposal that is much underutilized.

#### 8\* TABLED UNTIL NEXT MEETING

- Discussion regarding inadequate parking and its impact on a particular residential neighborhood. (Attachment 10).
- Discussion regarding analysis of LADWP water bills for May/June cycle. One of the NC representatives researched the uniqueness of the computation of how this particular water bill in the yearly cycle was calculated.



#### Wajma Ahmady Written Candidate Statement

Shortly after the leak occurred in October 2015, I volunteered my time with the Save Porter Ranch and Food and Water Watch team. I attended trainings on how to contact news outlets and maintain an ongoing positive relationship with journalists. I was also briefed on legislation that our elected officials were working on, such as SB 887 and SB 888. On August 2 and 3, I traveled to the state's capitol in Sacramento with the Save Porter Ranch and Food and Water Watch team. I gave a speech at the press conference on the Capitol's building steps. I presented a case of one resident whose physiological, social, emotional, and psychological life has been ruptured as a result of living near the Aliso Canyon facility. Her story represented many residents' experiences. After I gave the speech, I was interviewed by Fox 40 and the Associated Press.

After the press conference, we attended a meeting with State Senator Fran Pavley regarding bills, such as SB 887 (Regulatory Reform) and SB 888 (Emergency Planning and Mitigation). Subsequently, we met with Governor Brown's office, where residents spoke about how the leaks have disrupted their lives, then and now. The weekend before that, we knocked on doors in the neighborhood to talk face-to-face with residents about their experiences. As a volunteer with Save Porter Ranch, I have cultivated a diverse set of skills and relationships. I can bring these skills and relationships with me to the PRNC, including bringing more visibility to the PRNC, bringing in volunteers with expertise in areas such as a sustainability committee, legislative, etc. These experiences have shaped my understanding of the community and the important issues affecting them, as well as how we can continue to build and strengthen networks for the future.


