I first starting assisting neighborhood councils 12 years ago when I took over maintaining websites for the three San Pedro NC's. As time went on they wanted to upgrade the websites so we sat down with several board members and developed an overall template that would work for managing NC information and make agendas, news, minutes, events, etc easily organized and accessible. Below you will see URL addresses to various NC websites that I manage that use our template. Some are slightly different as they were updated more recently. Since becoming an official vendor, I have made agreements with many NC's to manage their website from Wilmington all the way up to Chatsworth.

Our template features meetings and events as the main focus since we realize that your NC's are pretty much meeting driven. We have a column for news on the right side. We can also feature something special such as an event coming up or news that you want to give special attention to just above the meetings and events. The buttons and tabs are all customizable to fit your needs.

We charge \$600 to create your website using our NC template. This means customizing it with your logo, colors and any photos for the background that you might like to feature. Included in that \$600 we also transfer all your current website data (past minutes etc) into the new pages that we create. Once the website is fully functional and launched, **we charge a flat fee of \$100 per month for maintenance.** This includes daily uploading of agendas, minutes, current news, events, links, etc.

If you also want to have our company **host your website, the cost is \$15 per month** and can be billed monthly or annually. We do prefer to host the website so that there are no issues in utilizing our template on another hosting site as we found some not be as fast a speed or they have different parameters than the hosting company that we utilize.

A bit about me.... I am passionate about neighborhood councils and have worked with some amazing people over the years who volunteer their time for their communities to make them better. In turn, I keep my rates low so that more of your funding can go to important community projects.
